3. Election: Fill Vacancy of Executive Committee

By motion of Barbara Horl, and seconded by Eric Friedman the Council accepted the nominating committee's nomination, and elected President David Stout to fill the vacancy on the Council's Executive Committee. 4. Approval of Minutes

By motion of Mark McCormick, and seconded by Dot Hall, the minutes of the of March 17, 2025 Executive Committee meeting; March 24, 2025 Council meeting; April 14, 2025 Executive Committee meeting; and May 19, 2025 Executive Committee meeting were approved without amendment.

5. Acceptance of Council Financial Statements

By motion of Dot Hall, and seconded by Margaret McMenamin, the Council accepted the financial statements for March 2025, April 2025, and May 2025.

6. Report on Temporary Investments

The Council currently keeps its cash reserves in an account with Spencer Savings Bank. The Council is also enrolled in the NJ Cash Management Fund. As of May 31, 2025, the Council's NJ Cash Management Fund holdings are \$2,379,962.

7. Action: Resolution to Issue RFP for State-wide Economic Impact Study

By motion of Jessica Purnell, and seconded by Margaret McMenamin the Council adopted the

resolution to issue an RFP to conduct an Economic Impact Study of community colleges in New Jersey, rescinding the Council vote on April 22, 2025. Warren abstained.

12. FY2026 State Budget and Legislative Update

• FY2026 State Budget

Heidkamp reported, in the last weeks, we have learned that our request to the State Legislature for a resolution to restore \$20 million in operating aid in the FY2026 state budget is on track due to the widespread support of legislators across the state. The resolution will take the form of a "common resolution" that is supported by Senate and Assembly leadership. We are hopeful that the State Legislature will restore funding for the Summer Tuition Assistance Grant (Summer TAG) program in the FY2026 state budget as well. We will continue to keep the Council updated as things take shape.

Legislative Update

Heidkamp reported that we have made significant progress in the State Legislature on all of the six Opportunity Agenda bills, including the County College Contract Law. The bills have been considered by the full Assembly and by various Senate and Assembly Committees. We expect some movement on the bills through June 30, but will be prepared to work with the State Legislature through the "lame duck" session as necessary.

13. Other Business

Jessica Purnell discussed the upcoming ACCT Awards with the Council encouraging members to submit nominations. The full details for the ACCT Awards and nomination process will be

forwarded to the Council following the meeting.
