II. Business

3. Approval of Minutes

By motion of Margaret McMenamin, and seconded by Barbara Gaba, the minutes of the of November 11, 2024 Executive Committee meeting; November 18, 2024 Council meeting; December 16, 2024 Executive Committee meeting; January 27, 2025 Executive Committee Meeting; and February 17, 2025 Executive Committee meeting were approved without amendment. Cory Homer and Michael Goldberg abstained.

4. Acceptance of Council Financial Statements

By motion of Deborah Preston, and seconded by Lovell Pugh-Bassett, the Council accepted the financial statements for November 2024, December 2024, January 2025, and February 2025. Cory Homer and Michael Goldberg abstained.

5. Report on Temporary Investments

The Council currently keeps its cash reserves in an account with Spencer Savings Bank. The Council is also enrolled in the NJ Cash Management Fund. As of February 28, 2025, the Council's NJ Cash Management Fund holdings are \$2,702,828.

6. Action: Acceptance of NJCCC FY2024 Audit

By motion of Dot Hall, and seconded by Anthony Iacono, the Council accepted the NJCCC FY2024 Audit.

7. Discussion: Proposed NJCCC Bylaw Amendment- Refocus and Rename Economic Mobility Committee

Fichtner and Lovell Pugh- Bassett reviewed the proposed bylaw amendment with the Council members including the proposed rewritten charge. Further the committee is recommending that its name be changed to the Economic and Community Vibrancy Committee to reflect this broader mission and charge. In addition, the committee is recommending that the Council's Advisory Committee on Racial and Social Justice be merged into the Economic and Community Vibrancy

Committee. This By-Law Amendment will be officially considered at the June 16, 2025 Council meeting.

III. STRATEGY

8. State Budget

• Governor's Proposed FY2026 State Budget

Fichtner reviewed the Governor's proposed budget with the Council. The budget includes the following cuts: 1. Community College Operating Aid- \$20,000,000; 2. CCOG - \$7,280,000; 3. Student Success Incentive Fund- \$2,500,000; 4. Center for Adult Transition- \$1,800,000; 5. College Readiness Now- \$136,000; 6. DSP Career Development - \$500,000 (Total Community Colleges Cuts- \$32,216,000.) The Workforce Consortium Pathways funding was kept level at \$6,000,000.

Proposed Strategy and Timeline

Fichtner reviewed the strategy which consists of relentless engagement with the Legislature; increased involvement of student leaders, college leaders, trustees, and community partners and supporters; and getting partners involved including business, social justice, and community-based organizations, and counties.

• Budget Hearings Update

As budget hearings dates are set, the Council staff will reach out for presidents, trustees, and students to testify accordingly.
